5. Two Bid System shall be followed for this tender. Bid Evaluation Criteria at Annexure – IV of the Bidding Documents shall be the basis for evaluation of tenders.

6.0 Pre-Bid Meeting / Conference:

6.1 Pre-Bid Conference (PBC) will be held on date & time mentioned in table above at to be CDWG, Central Procurement Department 15th Floor Maker Tower E, ONGC, Captain Prakash Pethe Marg, Cuffe Parade, Mumbai, Maharashtra 400005 (OR through Video- conferencing on Microsoft Teams) for the purpose of clarification of points on technical and commercial issues relating to the tender documents, if any. Bidders are advised to download the tender documents well in advance to pre-bid conference date, providing sufficient time to response.

The bidders are requested to upload query / clarification on tender documents in the C-folder, Bidders correspondence areas, pre-bid queries, through website <https://etenders.gov.co.in> on or before last date mentioned in table above for the purpose of discussion in pre-bid conference.

No further queries / clarification on tender documents will be entertained / accepted by the Corporation.

6.2 Bidders are advised to depute their authorized and accredited representative (maximum 03 persons per bidder) of appropriate rank to attend pre-bid conference to take decision across the table. While submitting queries prospective bidder(s) shall be required to provide undertaking as per Appendix- 11 PBC of Annexure-I (ITB) along with details (name, designation, mobile no. etc.) of its representative who will attend PBC and those person (s) only will be permitted to attend PBC.

Please refer clause 6 of Instructions to bidders.

6.3 Any modification to the tender documents, which may become necessary as a result of the pre-bid meeting, shall be made by the Corporation exclusively through issuance of an amendment to tender documents and not through record notes of the pre-bid meeting.

6.4 Failure to attend the pre-bid conference does not restrict the Vendor from submitting the bid.

7.0 Bidders also to note that one agent cannot represent two bidders.

8.0 e-Tender (un-priced techno-commercial bid) and price bids submitted in physical form against e-procurement tenders shall not be given any cognizance.
